  - 3. The various stages of prayer according to the spiritual writings by the Doctors of the Church
  - 4. How to practice meditation, including making a daily resolution[s].
- 3. Learn how to teach others to pray/meditate
- 4. Accept the responsibility to participate in the Mission of Christ
  - 1. Taking Holy Initiative
  - 2. Having a strategy for making disciples

#### **Spiritual Mentorship**

What then is Spiritual Mentorship?

"It is the guiding of a person into a life truly under the dominion of the Holy Spirit, who is the primary director." It helps the mentee to become more "docile to the light and promptings to the Divine Sanctifier, identifying impediments to this, as well as ways to overcome them, giving instruction and encouragement in living a life of virtue, and assisting the mentee (sic) to advance on the path of prayer—the road to union with God." (*Seeking Spiritual Direction*, Thomas Dubay, S.M.)

Why Doesn't God Just Do It?

As stated above, the Spiritual Director is indeed the Holy Spirit. However, God, in His loving providence, desires to use human agency in carrying out His plans. He desires to draw us into His life and work to accomplish two things: to reveal His respect for our dignity and to sanctify human faculties by exercising supernatural grace. In other words, a loving Father desires to see his gifts translated to his children and to witness their growth. Can the laity accomplish the role as a Spiritual Mentor? Yes! The Vatican II Council states that all human activity, including lay participation in the common priesthood of the faithful, are to be carried out in the Holy Spirit (*Lumen Gentium*, §34). Fr. Dubay says, "even when competent non-clerical men and women offer spiritual guidance, their task participates in the…immense rich deposit…in accords with the Church's plan (Dubay 34).

### What Spiritual Mentorship is not

Spiritual Mentorship is not:

- 1. Counseling/Psychological analysis
- 2. Psychotherapy or interpersonal-problem resolution
- 3. Eastern programs or techniques
- 4. Confession

## Who is a spiritual mentor formed in our Catholic Spiritual Mentors Program?

"A Catholic Spiritual Mentor is someone formed by and under the auspices of the Holy Family School of Faith, who gives Catholic spiritual formation to another, teaching them to grow in holiness, virtue and a deeper prayer life according to Catholic Tradition." The protagonist in the relationship of Spiritual Mentorship is the Holy Spirit.

The Spiritual Mentor is a person who has a daily prayer life, seeks holiness, has respect for the Church, adheres to her teachings and has received adequate theological formation. A Spiritual Mentor is expected to teach and encourage and offer general principles of discernment to the person that he/she is mentoring.

- Have a spiritual director/mentor during the program and upon completion of it.

- Maintain confidentiality with mentee(s) during the program and upon completion of it.
- Exercise prudence before, during and after spiritual mentorship sessions with the mentee. This includes:
  - Not offering spiritual mentorship to persons of the opposite gender.

  - Not offering spiritual mentorship to minors.
